Assured Fitment™ by Glass and Metal Craft (G+MC) is an optional on-site measurement process performed by G+MC and used for the development of custom glass and metal hardware for complex architectural systems. By performing these measurements, G+MC can reduce the risk that the fabricated material will not fit per agreed upon specifications in the intended scope and/or space.

When the jobsite is deemed ready by the Customer and G+MC, G+MC will undertake the on-site measurement process in the presence of the customer, who will provide the necessary permissions and will support the process with key installation information.

Following the measurement process, if the delivered material does not fit in the intended scope and/or space, and Glass & Metal Craft determines that this was caused by incorrect measurements performed by G+MC, GMC will replace said material at its expense. Glass & Metal Craft reserves the right to have a qualified representative survey any alleged defective material and return this material to the factory for inspection before any warranty action is initiated.
